Dear Brothers

With this letter I propose a change to the Constitution of the P.R.Society, in Article 14. (SCHOLARSHIP FUND) that are conflicting with the Scholarship Fund Agreement and the Scholarship Regulations.

It presently reads: The Scholarship Fund shall be administered by a three member Scholarship Committee. Which decides on scholarship applications and is independent of the Supreme Lodge. The granting of scholarships and the raising of funds shall be conducted in accordance with the Scholarship Regulations. ~~The granting of scholarships and the amount of each scholarship shall be decided by the Supreme Conventions.~~

I propose that

1) It should be amended to read. The Scholarship Fund shall be administered by a 5, but not more than 7 members, 2 of which shall be members of the Supreme Lodge as per the Scholarship Agreement.

Also

2) It should be added. The applications are reviewed and approved by the Scholarship ,Committee.

3) Change the word **Regulations** to read **Scholarship Fund Agreement** from the paragraph. **The granting of scholarships and the raising of Funds shall be conducted in accordance with the (Scholarship Regulations.)**

4) Other additions.

The Final ARTICLE 14 of the constitution should now read:

ARTICLE 14

The Scholarship Fund shall be administered by a 5 but not more than 7 member Scholarship Committee, 2 of which are members of the Supreme Lodge.


This committee decides on scholarship applications and is independent of the Supreme Lodge. The applications are reviewed and approved by the Scholarship Committee.

The granting of Scholarships and the raising of funds shall be conducted in accordance with the Scholarship Regulations. (See separate Application for Scholarship and Scholarship Wards Rules and Regulations)

This Rules are authored by the Scholarship Committee and are subject to change and revisions depending on future conditions and circumstances that may dictate such changes and revisions and approved by a majority vote by the convention delegates.

The amount of each scholarship shall be decided by the Supreme Convention Delegates and must be in accordance with the Scholarship Agreement.
